BIG BROTHERS MENTORING

The Big Brothers mentoring program provides young people with a role model to talk to and share the experiences of growing up with.

Through regular outings, a relationship is developed between the mentor and the mentee, which is built on trust and common interests, and is supported by our experienced case-workers. The result is a life-changing experience for both the mentor and the mentee.

- Promote the importance of staying in school and healthy relationships with family and peers
- Instill trust and self-confidence in order to make healthy decisions
- Encourage leadership skills and independent thinking

MESSAGE FROM LEADERSHIP ==

We entered 2021 with many valuable lessons learned from the challenges that we had to navigate and overcome from the previous year. Although the pandemic continued to impact many aspects of our work and lives, the "unknown" element subsided, and our agency was able to concentrate on living into our mission and the essence of mentoring. Together we continued to create life-changing, developmental relationships that foster resiliency in the face of adversity.

We are proud to say that we supported 298 children and youth in the Langley community through our programs, keeping kids connected to essential support systems during a challenging time. Our amazing mentors continued to show up, demonstrating care, commitment and perseverance. We saw existing matches thrive, and made over 166 new connections through our one to one and group mentoring programs. A big thank you to our mentors – your generous gift of time and friendship brings us inspiration and fills our hearts.

2021 brought our agency many highlights and successes. In the spring, our board of directors and staff invested in a strategic planning process to determine our priorities and commitments for the next 3-5 years. The result of this work was our new 2021-2024 strategic plan, which identified specific priorities that will be integrated into our vision for mentoring programs in the Langley community and established goals that will guide our agency until 2024. This plan builds on our previous strategic plan, Vision 2020, and reflects 3 main pillars: Engagement, Innovation and Growth. We are eager to start a new chapter and begin putting these goals into action. In the fall, we embraced the return to in person mentoring programs at our partnering schools. Those first in person meetings and groups reminded us how much communication and connection is gained when we are face-to-face.

Our agency continued to experience uncertainty with our fundraising initiatives throughout 2021. We were excited to be back on the greens hosting our 33rd annual Golf for Kids Sake Tournament. This proved to be one of our most successful

tournaments ever, raising over \$71,000. It was, however, a disappointing year for our Big Deal Gala as provincial restrictions caused us to cancel our event. But we look ahead to 2023 with renewed hope that we will be able to celebrate mentoring with our community at our 3rd Annual Big Deal Charity Gala. This past year also brought an expansion of our partnership with Willowbrook Shopping Centre. We were thrilled to be the charity of choice for their annual Charity Shopping Night and to host the Christmas Wrapping station during the month of December. This partnership provided essential revenue at a time when we were unsure of the state of other fundraising initiatives.

We are both incredibly proud to lead the dynamic team of Big Brothers Big Sisters of Langley. Our staff team is the backbone of our agency and works tirelessly to build a better tomorrow for the youth in our community. Thank you for your resilience and flexibility, for thriving in an ever changing environment, and for your passion and dedication to this agency. We thank our Board of Directors who are deeply committed to our mission, and give so generously of their time, their experience and their hearts to achieving our vision. Your oversight and guidance is instrumental to our growth.

And finally, we would like to recognize all those who chose to make an investment in Big Brothers Big Sisters of Langley. Our success over this past year would not be possible without our tremendous supporters and partners who believe in the power of mentoring and recognize that when we unlock the potential in children, we are making a real and lasting impact in our community. Thank you for continuing to stand with us and staying committed to our cause. Because of your support, Big Brothers Big Sisters of Langley will be there to empower lives through mentorship now and in the future.

Big Sister, Angie said her connection with Angela is very positive, and always getting stronger!

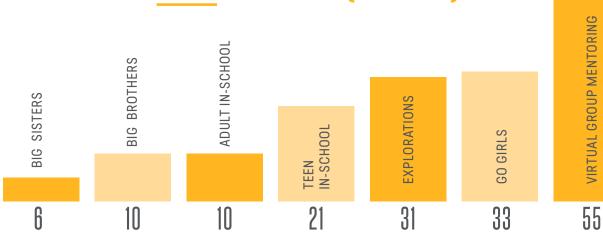
Angie said her Little Sister told her "people say I talk too much, but you really listen to me."
